

### You're Invited

The Lee County Department of Transportation (DOT) invites you to the Big Carlos Pass Bridge Project Development & Environment (PD&E) Study Hybrid Public Hearing on Thursday, January 28, 2021, at the Bay Oaks Recreation Center, 2731 Oak Street, Fort Myers Beach, Florida 33931. You may attend in person or join online at 6 p.m. (see information on back) for the formal hearing. The in-person hearing option begins with an open house at 5 p.m. and follows with a formal presentation and public comment period at 6 p.m. People attending the hearing can review project displays and speak one-on-one with project team members. These materials will also be available online for those people who attend virtually. Written statements or exhibits submitted at the public hearing, emailed, or mailed and postmarked by Thursday, February 11, 2021, will become part of the official hearing transcript.

### About the Project

Completed in 1965, the Big Carlos Pass Bridge spans Big Carlos Pass, connecting the Town of Fort Myers Beach with the City of Bonita Springs. The need for the project is based on a number of deficiencies of the existing bridge resulting from age and long-term exposure to the aggressive saltwater environment. As one of only two bridges serving the chain of islands forming Estero Bay, the Big Carlos Pass Bridge is a critically important infrastructure asset that must be maintained, making this project a high priority for both the County and the Metropolitan Planning Organization.

The study focused on the bridge and roadway approaches from approximately Estrellita Drive south to the entrance of Lovers Key State Park, a distance of about 0.6 miles. The project team developed and evaluated several alternatives including the no-build rehabilitation alternative, a new low-level drawbridge and a high-level fixed bridge. On January 18, 2018, Lee County DOT held an alternatives public meeting to present alternatives for rehabilitating or replacing the bridge.

On December 18, 2018, the Lee Board of County Commissioners approved the fixed span bridge on the Gulf side of the existing bridge as the preferred build alternative to move forward in the PD&E Study. Lee County DOT will present the preferred alternative and the no-build rehabilitation alternative at the public hearing. The no-build rehabilitation alternative will remain a viable option throughout the remainder of this study.

Project information and graphics showing the proposed improvements will be available for public viewing at two locations from January 4, 2021 to February 18 2021. The location will be the Fort Myers Beach Public Library at 2755 Estero Blvd, Fort Myers Beach, Florida 33931. The library is open from 9 a.m. to 5 p.m., Monday through Friday and 9 a.m. to 1 p.m. Saturday; closed on Sunday. The second location is at the Lee County DOT office located at 1500 Monroe Street, third floor, Fort Myers, Florida 33901. Hours of operation are 8 a.m. to 5 p.m., Monday through Friday. These project documents are also available online at the project website.

### What's Next?

After the hearing, final documentation will be submitted to the Florida Department of Transportation (FDOT) for approval. Upon FDOT acceptance, the project will advance to the design and construction phases as funding allows. The study must comply with the National Environmental Policy Act of 1969 (NEPA) in order to qualify for state and federal funding assistance.
